RESOLUTION TO EXCEED REVENUE CAP  
COMMENCING WITH  
THE 2018-19 SCHOOL YEAR  
BY AN AMOUNT NOT TO EXCEED \$450,000

BE IT RESOLVED by the School Board of the School District of Mondovi, Buffalo, Dunn, Eau Claire and Pepin Counties, Wisconsin, that the final school district budget shall include an amount not to exceed \$450,000 in excess of the revenue limits imposed by Section 121.91 of the Wisconsin Statutes each year for a period of three years on a nonrecurring basis, beginning with the 2018-19 school year and ending with the 2020-21 school year, for the purpose of paying District operating costs to maintain instructional programs, staffing, and technology.
