

## **SCHOOL DISTRICT OF MONDOVI INTERNET ACCEPTABLE USE CONTRACT**

Users of the School District of Mondovi's Internet are responsible for their actions and activities while using the Internet. The use of the district's Internet is a privilege, not a right; and inappropriate use may result in a cancellation of those privileges. Failure to follow the district's CIPA/Internet Safety/Appropriate Use policy and the Internet Acceptable Use Contract may result in disciplinary and/or legal action; students who seriously abuse the policy or contract may be suspended or expelled. When applicable, law enforcement agencies may be involved in the investigation of a suspected policy or rule violation.

Users of district resources should not regard any documents they create or store or any digital communication they send or receive as private. The School District of Mondovi reserves the right to access, review, monitor, copy, disclose, and/or download any stored information, communication, files or other materials created or maintained by any person, including coded, encrypted, or password protected material at any time. The School District of Mondovi is not responsible for any data corruption.

### Acceptable Use Guidelines:

1. Users are expected to follow all CIPA guidelines when using district technology resources. Sexually explicit content or innuendo, cyberbullying, racial slurs, sexist remarks, hate mail, harassment, discriminatory remarks, threats, and any other antisocial behaviors are unacceptable in Internet or other network communications.
2. The network is not to be used for any illegal activity or for transmitting any material in violation of any United States, Wisconsin, or School District of Mondovi Board of Education policy. This includes, but is not limited to, violation of copyright or other contracts.
3. The network is not to be used for financial or commercial gain.
4. Users must have an account assigned by the School District of Mondovi.
5. Users are to keep their passwords private and should log-off the network whenever leaving a desktop station.
6. Users are not to access a computer using an account that is not their own or modify the credentials or data of another user.
7. Users are to respect the privacy and property of other users. Users will not intentionally seek information about, obtain copies of, or modify, files, data, or passwords of other users.
8. Users will not intentionally provide inaccurate or dishonest information to individuals or groups.
9. Users will not post personal communications without the author's consent.
10. Anonymous messages are not permitted.
11. For safety reasons, users will not reveal any personal information such as addresses, phone numbers, or photographs.
12. Vandalism of any kind which degrades the data of another user or disrupts equipment or system performance will not be tolerated.
13. Software will only be installed or downloaded by the Instructional Technology Coordinator.
14. Computer games are not allowed unless part of a class/course curriculum.
